COURSE NO., HOURS, AND TITLE:

MHI 525, 3, Health Informatics Applications and Project Management

COURSE DESCRIPTION:

Students explore methods for designing and managing health care organization databases and their use in computer based information systems. Focuses is given on the impact that health care information systems have on administrative functions, data security and integrity, and business processes. Use of relational database management software, network hardware technologies, data modeling, clinical data warehousing and mining are explored, as well as, the tools necessary for successful system implementation and human computer interfaces.

- Understand the history and theoretical concepts of health informatics
- Integrate clinical, financial, and administrative data to resolve management and patient care issues.
